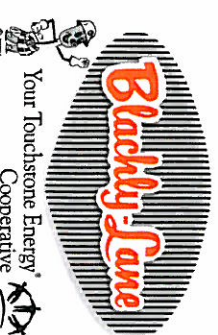

This Program is effective for the period October 1, 2011 through September 30, 2012. The program is for **existing electrically-heated homes** (not new homes or additions) located in Blachly-Lane's service area.

Eligible Measures:

- Insulation** items (floor, wall and attic). Rebate is 25% of the cost*.
- Windows:** Replacement with **class 30 (U= .30)** rated brand. Rebate is \$6 per square foot of window area*.

*The maximum rebate, insulation plus windows, is \$500 per customer per year.

- Duct Test and Seal** in accordance with **PTCS standards:**
 Manufactured Homes - \$400
 Single Family Homes (existing) - \$500
 Single Family Homes (new) - \$400

Financing Options: In place of a rebate or credit to the electric account, the following loan options are available:

- Zero interest loan up to \$500.
- Prime plus 2% loan up to \$3,000 limit from Blachly-Lane.
- PCB bank loan up to \$5,000 with Blachly-Lane buying down the interest rate three (3) percentage points.
